Senior Cadet Parking Spot Painting Agreement 2026-2027

Painting parking spots provides senior cadets with an opportunity to personalize their space in a manner that contributes positively to the DMA community and maintains a safe, respectful, and appropriate school environment. Participation is a privilege and is subject to the requirements outlined in this agreement.

In order to participate, the cadet agrees to the following:

1. **\$5 Painting Fee:** The fee must be paid before painting can begin. The fee covers the cost for our maintenance staff to repaint the spaces after graduation.
2. **DMA Approval:** The proposed design must be submitted to and approved by DMA administration before painting begins.
3. **Appropriate Content:** The design must be school-appropriate and may not contain content that is obscene, sexually explicit, vulgar, threatening, harassing, discriminatory, hateful, or otherwise inappropriate for a school setting.
4. **No Controversial or Divisive Images:** Designs may not include controversial, inflammatory, or divisive images, symbols, messages, or references that could reasonably create significant disruption or conflict within the DMA community.
5. **No Hate or Discriminatory Content:** Designs may not promote or express hatred, discrimination, harassment, or hostility toward an individual or group based on protected characteristics.
6. **No Weapons or Violence:** Designs may not depict or promote weapons, graphic violence, threats, or acts of violence.
7. **No Drugs, Alcohol, or Tobacco:** Designs may not advertise, promote, or depict illegal drugs, alcohol, tobacco, vaping products, or related activities.
8. **No Profanity or Inappropriate Language:** Designs may not contain profanity, vulgar language, sexually suggestive language, or other language inconsistent with DMA expectations.
9. **No Commercial Advertising:** Designs may not promote businesses, products, services, or commercial organizations unless specifically authorized by DMA.
10. **No Political Campaigning:** Designs may not be used to campaign for or against political candidates, political parties, ballot initiatives, or other political campaigns.
11. **Respect for Others:** Designs may not identify, mock, insult, threaten, or otherwise target another cadet, staff member, group, or community member.

12. **DMA Property:** Painting must remain entirely within the assigned parking space and may not cover or damage parking lines, curbs, sidewalks, drainage areas, signs, or other DMA property.
13. **Materials:** Cadets must use materials and painting supplies approved by DMA. Paint must be appropriate for use on asphalt or concrete and must not create a safety hazard.
14. **Supervision and Scheduling:** Painting may occur only during DMA-approved dates, times, and locations and may be subject to staff supervision.
15. **Clean Up:** Cadets are responsible for removing all painting supplies, containers, trash, and other materials when they finish.

Design Review and Approval

DMA reserves the right to review proposed designs before painting and to require modifications when a design does not comply with this agreement or applicable DMA policies.

Approval of a design does not necessarily mean that DMA endorses or agrees with the message, imagery, or viewpoint expressed in the design.

If a design is determined to violate this agreement after approval or painting, DMA may require the cadet to modify, remove, or cover the design at the cadet's expense.

Responsibility for Damage

The cadet and parent/guardian understand that the cadet is responsible for any damage caused by painting activities, including damage to DMA property or property belonging to others.

The cadet agrees to follow all DMA safety procedures and staff instructions while participating in the program.

Removal of Painting

The \$5 fee collected with this form covers the cost for our maintenance staff to repaint the spaces after graduation. Unless otherwise directed, cadets are not responsible for the removal of their painting after graduation.
